## Article 003 - Replace the Federal Income Tax

## Replace the Federal Income Tax

Let's face it, we all hate the Federal Income Tax as it stands today. At least, I do, and I am assuming that most of our readers feel the same way. So, instead of just griping about it, here are some suggestions that you might be able to think about and then write to your "representatives" in Congress and see what kind of response you get.

A lot has been said about the Fair Tax, the Flat Tax, and an assortment of other tax schemes, but here is one that I have not seen yet.

Here goes:

1. To start with, abolish in total, the Federal Income Tax. Before I go any further, I am talking about FEDERAL, not State or Municipal taxes.
2. Once this is accomplished, implement a 10% Federal Sales Tax on EVERYTHING at the final point of sale. That would include a 10% sales tax on all food and beverages.

3. Abolish ALL write-offs whatsoever. No more tax exemptions for Non-profits (including ALL religious denominations and their real estate holdings). No write-offs for charitable donations, stock losses, business expenditures, etc. No write-offs at all. No exceptions!

4. Now comes the good part. Since there are no write-offs whatsoever, there would be no payment of capital gains by the seller. The seller would be able to keep all profit - free and clear.

5. However, the seller would NOT be able to deduct any losses either.

6. As for people who live under the Federal Poverty Level, they would be given a “credit card” with a 25% discount on FOOD only. Any misuse of this benefit would be punishable by a fine and/or imprisonment.

7. All companies, corporations, and business operations would be obliged to file and submit their 10% sales tax monies on a quarterly basis to newly designated IRS Centers.

# Benefits of a 10% Federal Sales Tax

1. For starters, almost every religious belief system refers to a 10% tithing to be given as an offering to their stated religion. If 10% is good enough for God, then 10% is good enough for the Government!
2. This system would eliminate all withholding from workers' paychecks. They would take home 100% of their own earnings. And when people have more money, what do they do with it? They spend it.
3. This system would also close all local IRS centers, cut down on massive amounts of paper (save the trees), abolish all income tax regulations, and IRS tax collectors.
4. This system would eliminate ALL tax accountants, lawyers, the tax preparation industry (H&R Block), and all other forms of money making businesses that have glommed onto the IRS confiscation ruse.

7. The Government would no longer be able to take money out of workers’ paychecks - BEFORE they get it. It was YOUR money in the first place, the Government just took out too much, and is now returning it back to you - WITHOUT any Interest paid whatsoever. That sounds like a conspiracy to me!

## A Few Other Points To Consider

1. Please remember, every advertisement that you see on television is a TAX write-off for big companies and corporations. In other words, these organizations actually are advertising for free - and We the People, who have no such advantage - pick up the tab when we pay, the now existing, Federal Income Tax. Many of the biggest corporations in America have actually gotten away with paying NO Income Tax at all,

simply because of the myriad of LEGAL tax loopholes that exist to this very day.

2. Also, consider the fact that Bill Gates, for example, can donate to “charitable” organizations - of HIS OWN CHOOSING – write that amount off on HIS income taxes - and We the People, who have no say in who he gives his tax deductible donations to - must also pick up his tab, to boot!

3. As stated earlier, under this 10% Federal Sales Tax - there would be NO TAX Write-offs. If you REALLY want to donate to a worthy cause – then do it. But don’t be hypocritical about it, pretending to donate to worthy causes – and then turn around and stick We the People with the bill. If you wish to donate, fine. But do it on your own dime.

4. And if religious organizations complain, remember that under this system, all religious entities will no longer have to report how much money they receive as donations - because this income will no longer be taxed!

5. And one of the biggest advantages of this 10% Federal Sales Tax is that the Government will no longer be able to TARGET its ENEMIES by assigning Internal Revenue Service Tax Collectors

on those who disagree with the inner-workings of the Federal Government. This practice of IRS intimidation has been going on ever since the Federal Income Tax system was established in 1913 - by DEMOCRAT Woodrow Wilson, who also initiated the Federal Reserve - a PRIVATE institution run by UNELECTED Millionaires – who have TOTAL sway over the economic future of America - and, in essence - the World.
